

# **Contest Rules & Regulations for "Funny Wedding Photography".**

These regulations ("Regulations") specify the rules, scope and conditions for participation in the "Funny Wedding Photography" ("Competition Page") organized on Facebook and the Instagram platform.

## **I. General Provisions**

1. The competition is organized by Quadralite.
2. The benefactor of the prizes in the competition is Quadralite.
3. The competition runs from 10/02/2020 to 29/02/2020 ("Competition Period").

## **II. Who can take part in the competition?**

4. Participation in the competition is voluntary and free. Participants of the competition ("Participants" or individually "Participant") may be natural persons who are consumers within the meaning of art. 22 (1) of the Civil Code, having full legal capacity, which at the time of application in the competition have their place of residence in the territory of the Republic of Poland and/or European Union countries.

The above activities constitute the Participant's application to the Competition ("Competition Application").

## **III. What is the competition task? How does the competition operate?**

5. The competition consists of sending photographs selected by the participant during a wedding ceremony or wedding reception, in which unexpected in a positive manner (non-ridiculous and non-embarrassing) situations were captured.
6. The participant may take part in the competition once, sending up to 3 photos.
7. The participant may only submit his/her own photos. In cases of doubt, the jury may ask the participant to view the source file (s) to verify ownership and/or validity of ownership.
8. Pictures during the competition should be sent to the email address: [marketing@quadralite.pl](mailto:marketing@quadralite.pl), providing the Author's Name and Surname, contact details, consent to the free publication of works on the Competition Website, i.e. [http://quadralite.pl / blog /](http://quadralite.pl/blog/) [slubnenawesolo](#) and on FB @ [quadralite.lighting](#) fanpage.
9. The organizer appoints a Competition Committee, which includes:

10. These Regulations are the only document specifying the rules of the Competition.

11. In matters not covered in these Regulations, the provisions of the Civil Code applicable to the organizer's country shall apply

#### **IV. What can you win in the Competition?**

12. The prize in the Competition is:

I - MiLED 112

II - Quadralite AIR 260 tripod

III - Quadralite silver-white reflector with a 90x120 handle

13. The awarded prize is not exchangeable and is not entitled to a cash equivalent. The Organizer informs that if the winners of the Competition provide false, incomplete, or incorrect data, the prize may not be issued despite the Organizer's due diligence.

#### **V. Who will inform about the winners in the Competition (and how)? What do you have to do to collect the prize?**

14. Photos selected by the competition committee will be awarded by the Organizer. The organizer will announce the winners on the Competition Website, i.e. <http://quadralite.pl/blog/slubnawesolo> and on FB @ quadralite.lighting fanpage, within 24 hours of the end of the Competition.

15. At the latest, within 14 days of the end of the Competition, the Organizer will contact the Winners via [marketing@quadralite.pl](mailto:marketing@quadralite.pl) and the email address provided in the competition application, informing that they won.

#### **VI. What do you agree to by entering the Competition?**

16. Participants accept the content of the Regulations and agree to the processing of personal data for the purpose of conducting the Competition, for marketing purposes, and agree to receive commercial information, including newsletter and/or email (unless they are already subscribers to the Quadralite newsletter).

## **VII. What happens to the data provided by the Competition Participants?**

17. Participants' personal data will be processed by the Organizer in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95 / 46 / EC (general regulation on data protection) hereinafter referred to as "GDPR" for the purposes of conducting the Competition, selecting the winners, issuing prizes and settling the tax due. The administrator of personal data is Quadralite with it's registered office in Kraków at ul. Bonarka 11. Information on data processing by the Organizer has been provided to the Participant in the information clause. The participant has the right to access their personal data and correct it and/or demand its removal. Personal data may only be disclosed to entities authorized under the law.

Providing personal data and expressing consent by the Competition Participants is voluntary, but necessary to participate in the Competition.
